



## **Exhibitor Liability Insurance Program**

As a standard requirement for all our show exhibitors, it is necessary for you to carry general liability coverage from an insurance company in good standing with minimum policy limits of \$1,000,000 per occurrence and \$2,000,000 aggregate. Insurance Coverage is not optional.

This insurance must be in force during the lease dates of the event October 12-20, 2025, naming the International Fresh Produce Association (1901 Pennsylvania Ave. NW Suite 1100 Washington, DC 20006) as the certificate holder. The following must be listed as additional insured: International Fresh Produce Association IFPA/ The Global Produce & Floral Show 2025, Aramark, GES and Anaheim Convention Center and the city of Anaheim.

## **Rainprotection Insurance Program**

If you do not have insurance, or you would rather not use your own insurance, (similar to when you rent a car – so that claims would not be filed against your policy), we have set up a program with Rainprotection Insurance through which, you can purchase compliant insurance instantly online.
